Ref: Urgent Switzerland WHO BioHub and Spiez Laboratory Dual Use and Gain of Function Risks

Dear President Trump,

We are writing to you jointly as a Swiss citizen engaged in laboratory-analysis, environmental modifications, civic and democratic advocacy and as a senior German scientist with decades of experience in toxicology, immunology, and biological risk assessment, including dual use and gain of function related research.

This letter addresses an urgent and escalating international security concern centered in Switzerland, namely the operational integration of the World Health Organization with the Swiss federal high security laboratory in Spiez, and the associated WHO BioHub System.

Switzerland has become the central operational base of the WHO. This role now extends far beyond coordination and advisory functions and increasingly involves the handling, storage, transfer, and research of high risk pathogens. These activities include dual use capable research and gain of function relevant work, conducted under WHO frameworks and diplomatic immunities.

These programs were established and expanded without explicit democratic authorization by the Swiss Parliament and without a mandate from the Swiss population. In a direct democratic constitutional system such as Switzerland, this constitutes a profound legal and constitutional breach.

The WHO BioHub cooperation with the Spiez BSL 4 laboratory represents a convergence of global health governance, high risk biological research, and international political power,



operating without transparent oversight, independent auditing, or meaningful parliamentary control. This creates not only national constitutional concerns, but global biosecurity risks.

As you yourself have publicly stated, time is running out to stop a potential lab leak scenario in Switzerland. You have correctly warned that the WHO leadership, under Dr. Tedros Adhanom Ghebreyesus, has failed to act transparently and has actively obstructed accountability regarding the origins of Covid 19, including by appointing conflicted actors to investigate the Wuhan laboratory. These same leadership failures now manifest in Switzerland.

We further draw attention to the fact that pandemic exercises, pathogen aggregation, and centralized bio clearing house functions are now being conducted under WHO authority on Swiss territory, shielded by diplomatic status. Every delay in restoring accountability increases the risk of another global catastrophe.

One of the undersigned, Prof. Dr. Stefan W. Hockertz, has been subject to sustained professional and political persecution following early public warnings about Covid related misconduct, the Wuhan lab leak hypothesis, and the dangers of unregulated dual use and gain of function research. His experience is directly relevant to the present situation and illustrates the broader pattern of suppression faced by scientists who raise legitimate safety concerns.

We hereby explicitly incorporate by reference Prof. Hockertz's detailed scientific and legal assessment, originally addressed to Dr. Robert Malone, concerning WHO misconduct, lab leak risks, and gain of function governance failures. That document forms an integral part of this appeal and is available for review and submission as an annex.

We respectfully request your attention and principled engagement to support:

1. Immediate independent international investigations into the WHO BioHub System and its cooperation with the Spiez laboratory
2. Full transparency regarding all dual use and gain of function related research conducted under WHO authority in Switzerland
3. Review of the legality and constitutional basis of WHO operations on Swiss territory
4. Restoration of democratic oversight, parliamentary control, and national sovereignty
5. Accountability of WHO leadership for past and ongoing obfuscation of laboratory origin risks

The possibility of a United States exit from the WHO in 2026 has already triggered global debate. Many now ask whether such a step could mark the beginning of a broader restoration of sovereignty, transparency, and lawful international cooperation.

Dear Robert,

we have spoken in conference calls before and also met and spoke together in Bern, Switzerland on November 12, 2021.

We are writing to you jointly as a Swiss citizen engaged in laboratory-analysis, environmental modifications, civic and democratic advocacy and as a senior German scientist with decades of experience in toxicology, immunology, and biological risk assessment, including dual use and gain of function related research.

This letter concerns a serious and escalating public health and governance issue centered in Switzerland, specifically the operational role of the World Health Organization and its cooperation with the high security laboratory in Spiez.

Switzerland has become the primary operational hub of the WHO. This role now extends far beyond coordination and advice and increasingly involves direct participation in high risk biological programs, including pathogen aggregation, storage, transfer, and research with dual use and gain of function relevance.

These activities were established and expanded without explicit democratic authorization by the Swiss Parliament and without a mandate from the Swiss population. In a direct democratic system, this constitutes a profound breach of constitutional principles and public trust.

The WHO BioHub System and its integration with the Spiez BSL 4 laboratory raise fundamental ethical and safety concerns. Public health governance must be grounded in transparency, accountability, and informed consent. Shielding high risk biological activities behind diplomatic immunities undermines these principles and creates unacceptable global safety risks.

We respectfully ask for your engagement in support of:

1. Independent investigations into the WHO BioHub System and its Swiss operations
2. Transparency of all dual use and gain of function related research conducted under WHO authority
3. Ethical and legal review of WHO immunities where public safety is at stake
4. Protection of scientists and physicians who raise legitimate safety concerns
5. Restoration of democratic control in global health governance

Public health cannot be sustained through secrecy or coercion. It requires trust, accountability, and respect for constitutional order.

Dear Robert,

I am writing to you today because I would like to ask for your help in my own matter. I have been an important critic of COVID-19 regulations in Germany from the very beginning. I translated Kennedy's book "The True Fauci" and your book "Lies My Gov't Told Me" into German for Kopp Verlag. On my Telegram channel <https://t.me/ProfHockertz>, I have been campaigning for human rights and peace for years and calling for an investigation into the crimes committed in connection with COVID-19.

Robert Kennedy has now sent a groundbreaking letter to German Health Minister Warken, denouncing the legal action taken against scientists and doctors who have opposed the coronavirus regime. And this is where I am asking for your help. Since August 2021, I have been completely dispossessed in Germany due to a questionable tax charge. It is perfectly clear that this is a political trial aimed at silencing me as a scientist.

Expropriation means that the German government completely ruined me financially (properties completely stolen), so that I had to go to Switzerland to start over at the age of 65. Since the expropriation in 2021, there has been no court proceedings to clarify the allegations (it concerns double taxation between Germany and Switzerland), which violates every human right and continues to paralyze me up to this day. However, I continue to fight actively for people affected by the coronavirus regulations and the vaccination, especially children, and I am actively committed to fighting corruption and other crimes against humanity.

Ref: Verfassungsrechtliche Bedenken, WHO BioHub und Labor Spiez

Sehr geehrte Damen und Herren des Bundesrates,

wir wenden uns gemeinsam an Sie als Bürger der Schweiz und als wissenschaftlicher Experte mit langjähriger Erfahrung in toxikologischer, immunologischer sowie biologischer Sicherheitsforschung, einschliesslich Dual Use und Gain of Function relevanter Fragestellungen.

Gegenstand dieses Schreibens ist die verfassungsrechtlich problematische Rolle der Weltgesundheitsorganisation auf Schweizer Territorium, insbesondere im Zusammenhang mit dem Labor Spiez und dem WHO BioHub System.

Die Einbindung des Bundeslabors Spiez in internationale WHO Strukturen, einschliesslich der Sammlung, Lagerung, Weitergabe und Erforschung hochriskanter Pathogene, erfolgte aus unserer Sicht ohne explizite Zustimmung des Parlaments und ohne demokratische Legitimation durch das Schweizer Volk.

In einem direkt demokratischen Rechtsstaat ist dies nicht hinnehmbar. Souveränität liegt beim Volk. Tätigkeiten mit globalem Risiko und möglichem militärischem oder sicherheitsrelevantem Dual Use Charakter erfordern zwingend parlamentarische Kontrolle, rechtliche Transparenz und öffentliche Rechenschaft.

Die extensive Gewährung diplomatischer Immunitäten an die WHO verhindert eine wirksame rechtliche Kontrolle dieser Aktivitäten und stellt einen Verstoss gegen grundlegende rechtsstaatliche Prinzipien dar. Gleichzeitig wird die Neutralität der Schweiz durch die faktische Einbindung in internationale sicherheitsrelevante Strukturen untergraben.

Prof. Dr. Stefan W. Hockertz, Mitunterzeichner dieses Schreibens, verfügt über ausgewiesene Expertise im Bereich biologischer Risiken und war frühzeitig an der wissenschaftlichen

Wir fordern den Bundesrat daher nachdrücklich auf:

1. Die rechtliche Grundlage sämtlicher WHO Aktivitäten in Spiez offenzulegen
2. Eine unabhängige verfassungsrechtliche Prüfung einzuleiten
3. Alle Dual Use und Gain of Function relevanten Programme unverzüglich zu suspendieren
4. Die parlamentarische und öffentliche Kontrolle wiederherzustellen
5. Die Neutralität und Souveränität der Schweiz aktiv zu verteidigen

Die Sicherheit der Schweizer Bevölkerung und die verfassungsmässige Ordnung dürfen nicht internationalen Organisationen ohne demokratische Legitimation überlassen werden.
